Good morning Hanyu

I refer to your FOI Application (ref: **FOI2025-008**) made to the Department of Primary Industries and Regional Development (DPIRD) on 7 April 2025.

The decision maker for this application has been unwell since Monday 12 May 2025, and we have been hoping that she will return to the office in time to be able to finalise your application by the due date.

She is unlikely to return before next week, so we are requesting a 2 week extension of time in order to be able to provide you with a Notice of Decision.

If you are agreeable to the extension, then the revised due date will be 6 June 2025.

Can you please advise by close of business tomorrow **22 May 2025** if you are agreeable to the extension of time? If we do not receive a response from you and the application cannot be finalised within the permitted period, this is considered a deemed refusal of access pursuant to section 13(2) of the FOI Act.

Review rights are available to you. An application for internal review must be lodged with the DPIRD within 30 days after being given this written notice (ie 20 June 2025) and must:

- be in writing;
  - provide particulars of the decision to be reviewed; and
  - give an address in Australia.

There is no lodgement fee for an application for internal review nor are there any charges associated with such a request.

If an application for internal review is received, it will not be dealt with by the person who made the initial decision, or by any person who is subordinate to the original decision maker. The outcome for an application for internal review may result in confirmation, variation, or reversal of the initial decision under review. You can lodge an internal review request by email at foi@dpird.wa.gov.au.
