I am writing to notify your committee of the outcome of a recent Freedom of Information (FOI) process regarding animal welfare enforcement records in Western Australia.

In June 2025, the Department of Primary Industries and Regional Development (DPIRD) formally stated—under FOI2025-008—that no records exist summarising Designated Inspector (DI) inspections, enforcement outcomes, or internal performance reviews from 2022–2025, apart from a single summary spreadsheet.

This official confirmation of a record-keeping gap in the use of expanded DI powers raises significant questions about transparency, public accountability, and the efficacy of oversight in animal welfare regulation.

Dear ABC team,

I am contacting you regarding a recently completed Freedom of Information (FOI) process which has revealed a significant regulatory records gap in Western Australia's animal welfare enforcement.

My FOI application (FOI2025-008) asked the Department of Primary Industries and Regional Development (DPIRD) for basic summary records about Designated Inspector activities, inspection outcomes, and internal audits from 2022-2025.

DPIRD's formal response confirmed that **no such records exist**, other than a single summary spreadsheet lacking any dates or outcome details.

The absence of even the most fundamental regulatory documentation for a system with expanded legal powers over farmed animals raises profound questions about transparency, accountability, and the reality of state oversight.

I am writing to share a public record concerning regulatory transparency in animal welfare enforcement in Western Australia, which may be of interest to your organisation's ongoing work.

Following a recent FOI process (FOI2025-008) with the Department of Primary Industries and Regional Development (DPIRD), it was formally confirmed in June 2025 that no systematic inspection records, non-compliance summaries, or performance reviews are held for the use of Designated Inspector (DI) powers from 2022 to 2025, with the exception of a single summary spreadsheet with no inspection outcomes or dates.

This record-keeping gap has implications for both public accountability and the effective oversight of animal industries in WA.


