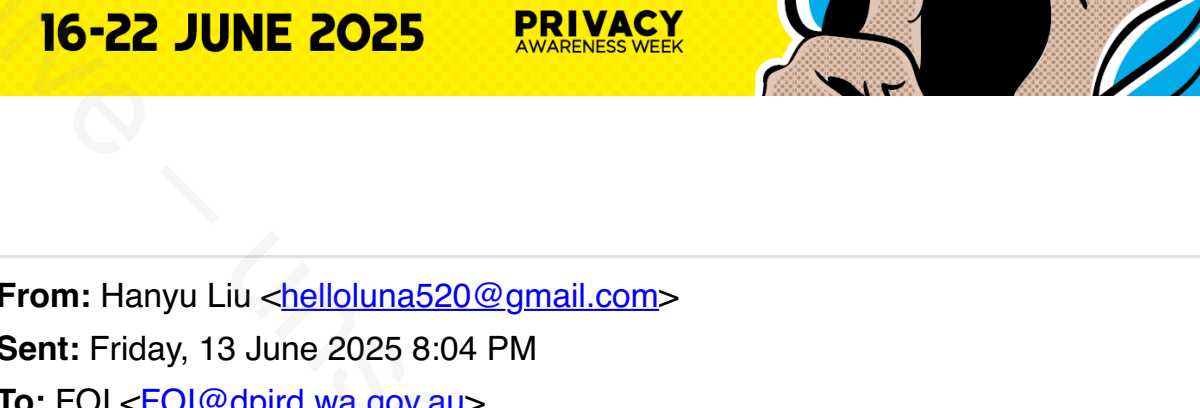

I request an internal review of the Notice of Decision issued on 30 May 2025 regarding FOI2025-008 (request for Designated Inspector inspection, enforcement records, and internal performance reviews from 2022–2025).

1. The provided document (Document 1: Facility Inspection Summary) is vague, generic, and lacks substantive inspection results or enforcement outcomes.
2. The claim that no inspection outcome data exists (Section 26 refusal) appears questionable and merits re-examination.
3. The claim that no internal performance reviews or audits exist (Section 26 refusal) similarly requires confirmation.
